## 1. Call to Order

### 5. Program Administration Report

Kathy Kamp (WPHD) reported that the Community Development Policy & Procedures Manual draft revisions are almost finished. She also reported on applications that have

been received and are in process. Kathy then discussed a checklist printout detailing the different stages that a project will go through from initial eligibility to completion.

#### 6. HOME Consortium Program Funds Reallocation

Colin Byrnes presented an amendment to the Mutual Cooperation Agreement between the City of Janesville, the City of Beloit, and the County of Rock for the distribution of Federal HOME Program Consortium funds. The two primary amendments are: 1) the one-time transfer of unallocated 200, 2010, 2011, and 2012 HOME funds in the amount of \$267,440.67 from Rock County to the City of Janesville and 2) Fifteen percent (15%) of the reallocated funds are to be used for HOME eligible activities or projects administered by Community Action of Rock and Walworth County, Inc. on a county-wide basis.

Com'r Grahn moved the approval of the Amendment to the Mutual Cooperation Agreement; seconded by Com'r Beaver. All in favor – **APPROVED** (Yes -5, No -0, Absent -0)

Commissioner Wood moved to adjourn the committee at 9:00 am; second by Commissioner O'Connell. **ADOPTED** by acclamation.
