<u>Fair Board Report</u> – None – tonight is the Fair Association Annual meeting at the fairgrounds.

Fairgrounds Maintenance and Contracts

Brian reported no new contracts; maintenance is going well.

<u>Discussion & Possible Action regarding possible changes in the fairgrounds rental rates</u>

Brian discussed the attached proposal (listed below) which balances the need to increase revenue with a more customer friendly process.

Fair Ground Rental Rates

In order to make the facility and renting process easier and more customer friendly, I propose that we raise and simplify the rates for renting space at the Rock County Fairgrounds. To justify raising the rates, the county will automatically include the garbage fee, heat, and air conditioning fee (Air Conditioning will be added to the Craig Center spring 2017). The rental price will also include the use of all the tables and chairs. The current inventory of tables and chairs could be purchased from the Fair Board at a price of \$2,500. Increasing the rates would also help meet the increased revenue proposed in the 2017 County Budget

Current Prices (Have not increased since 2014)

For- Profit

Monday - Thursday \$385/day Friday - Sunday \$420/day

Non-Profit

Monday – Thursday \$290/day Friday – Sunday \$305

Heat surcharge \$70/day Nov. 1st through April 1st

Optional Garbage Fee \$50

Currently Rented from the Rock County Fair Board Tables are \$7 each Chairs are \$1 each

Deposit \$50 or \$100 depending on event and location rented

Purposed Fair Grounds Rental Rates (Effective January 1, 2017)

Craig Center

Non-Profit = \$550 a day Profit = \$700 a day Setup and Cleanup days = \$200 a day if the date is open

Other Buildings and Green Space

All paid users = \$400 per day Setup and Cleanup days = \$100 per day

Alcohol permit = \$100 a day Key Deposit = \$50 per event

The rental rates would include any table and chair needs, garbage fees, and utility surcharges. If a group would like to bring their own tables and chairs, they can elect to deduct \$50 from the total.

Each event may be reviewed separately.

Need to discuss and determine who gets charged and who doesn't. Also need to get a handle on groups setting up and cleaning up and what the charges are for those extra

days. Craig Center and Main Gate will have electronic locks that will be set for the contract dates and times.

The plan is to purchase the tables and chairs from the Fair Board. Action on this agenda item will be deferred until the December 14th AE Meeting.
