1. Call to Order

2. Adoption of Agenda

Supervisors Heidenreich and O'Connell moved the adoption of the agenda. All in favor – **ADOPTED**

3. Minutes of Meeting for May 8, 2017

4. HOME Program Loan Requests

5. Program Administration Report

Kathy Kamp introduced new staff member Jerusha Daniels, Senior Project Manager for the Wisconsin Partnership For Housing Development to the commissioners.

Kathy Kamp provided the commissioners a financial summary of HOME Program funds available and potential projects that are currently in the pipeline. Ms. Kamp also indicated that while HUD currently has a moratorium on the deadlines for expenditure of funds, the remaining 2013 funding allocation should still be committed in the next few months to ensure that the funds are not withdrawn.

Director Byrnes reported on the joint HOME Program Consortium plans for writing an Affirmatively Furthering Fair Housing Plan. Possible sources of funding for the writing of the plan were discussed.

6. <u>Citizen Participation, Communications and Announcements</u>

Director Byrnes provided information on Rock County's sponsorship of the HomeBuyer's Education Workshops that are conducted by the Neighborworks – Blackhawk Region organization. The commissioners discussed various options and levels of providing sponsorship that would begin in budget year 2018. It was suggested that a representative of the Neighborworks organization attend a future meeting of the Housing Authority to provide more information on how the sponsorship funds are being utilized.

7. Next Housing Authority Meeting

The next meeting of the Rock County Housing Authority will be tentatively scheduled for Monday, July 17th at 8:30am.
