- 1. Call to Order: Chair Bostwick called the meeting to order at 7:01 p.m.
- 2. <u>Approval of Agenda</u>: Supervisor Driscoll moved approval of the agenda for July 11, 2018, second by Supervisor Aegerter. ADOPTED
- 3. <u>Approval of minutes from June 13, 2018:</u> Supervisor Driscoll moved approval of June 13, 2018 minutes, second by Supervisor Aegerter. ADOPTED
- 4. <u>Citizen Participation, Communication and Announcements</u>
  Supervisor Davis wanted to make sure everyone got the Farm Bureau cancellation notice for Meyer's.

## **UW-Extension**:

5. Rock County UW-Extension staff and program updates

a. Statewide Situational Needs Assessment Discussion – Chrissy Wen, Area 19 Director

Ms. Wen explained that Cooperative Extension is completing a Statewide Situational Needs Assessment to seek out the strengths and needs of counties, especially themes occurring in multiple counties or items of high prioritiy. Ms. Wen stated she will also be having this same discussion with the County Administrator next week. The committee discussed the County's top strengths and needs and Ms. Wen will forward that info on in her report due the beginning of August.

- b. Positive Youth Development Report Nancy Brooks
  Nancy Brooks summarized her report identifying strengths and challenges of
  Rock County youth and families. Interviews were conducted with community
  partners and questions were asked based on an ecological model of three levels.
  She noted a major challenge that was expressed by most partners she talked to
  was poverty, while one of the greatest strengths was family support from the
  community (looking out for one another). She also noted high praise for service
  providers but there was a great need for more of them. Ms. Brooks explained her
  report was just one piece of information in a large pot of Extension's ongoing
  assessment.
- c. Future Staffing and Program Needs Chrissy Wen, Area 19 Director Ms. Wen directed the Committee to the provided costing sheet analysis for a county funded 4-H Coordinator vs. Postive Youth Development Educator in response to discussions at the last meeting.

Laura Vanderveen, 4-H Program Coordinator, described to the Committee what she's been focusing on in 4-H and her goals for programming. She emphasized the size of Rock County's 4-H populations (largest in the state) and how it would greatly benefit the program to have a Coordinator/Educator vacancy filled.

Chair Bostwick questioned the state's status on filling the 4-H position. Ms. Wen stated Extension is currently at funding capacity for FTE positions that the budget can support. Chair Bostwick wondered what that meant for the vacant Horticulture position? Ms. Wen did not have information on the status of the Horticulture vacancy. The Committee expressed concern what message a lengthy position vacancy would send to the State and what future State support would be if the County started fully funding positions. Discussion ensued. Chair Bostwick supports lobbying for filling the 4-H/Youth Development position and stated it will need to be brought forth to Josh Smith and County Board.

#### d. Farm Update

Mr. Baker is hosting and/or speaking at two field days tomorrow, July 12<sup>th</sup>. He mentioned the new shed is a work in progress and completion deadline was 10 days ago. There were multiple issues with the sub-contractor that are being worked through.

Mr. Baker stated the Farm Lease is up after this year and is looking for any input from the Committee on changes to the next Lease Agreeement that may need to be made. He noted the BASF is happy with their research plots and that's a positive thing for the Farm.

6. <u>Discussion and Possible Action on UW Extension Office Move</u>
Supervisor Driscoll moved approval of the Extension office move, second by Supervisor Sweeney. ADOPTED

Brent Sutherland, Facilities Management Director, explained the timeline of events and benefits to the County for moving the Extension office to the vacant Adolescent Service Center on Highway 51 near the Health Department. He hopes to have the building ready to occupy in October since Facilities Management staff is doing much of the renovating.

Supervisor Sweeney felt it's a good location for the department. He questioned what security measures are being discussed? Mr. Sutherland stated security is a priority in all of the County buildings, but there's no decisions yet what that will look like for this particular building (keycode, card access, cameras, etc.)

Mr. Sutherland invited Committee members to come tour the new building. It was suggested having future meetings at both the farm shed (upon completion) and the new building when it's closer to completion.
