## 7. Fair Board Report

Thompson reported on behalf of John Quinn. Wednesday, November 18<sup>th</sup> is the Annual Fair Association meeting at the Craig Center. Supervisor Owens asked about the status of relocating the Fairgrounds. Thompson reported that the Fair Board is currently not discussing the issue. Lease/income from the cell towers was discussed by Thompson in response to questions from Supervisor Owens. Replacement of perimeter fence was also discussed.

## 8. Approval of County Farm Cropland Lease Contract:

Baker presented the bid information. Only 2 (two) bids were submitted. Badgerland Grain Farms had the highest bid of \$267.86/acre for a total of \$105,000 per year. The rate for the last contract was \$357/acre. The decrease is based on commodity prices. Baker recommended approving the Badgerland Grain Farm bid. Motion to approve by Supervisor Wiedenfeld, Second by Supervisor Sweeney, Motion carried.

### 12. Comments from the Committee

Supervisor Owens: concern over status of bees, bee habitat & pollination in the area, especially as it related to the food supply. Baker shared information about the local bee population & plans to keep it viable including bee-safe pesticide treatments.
