# **State EMS Board Update**

Chair Joe Murray reported there have been continued talks regarding about state wide protocols and that virtual meetings are still taking place.

# **EMS Providers – Municipal and Private**

- Chief Randy Pickering from Edgerton Fire reported they are doing well.
- Deputy Chief Joe Murray reporting nothing new from City of Beloit Fire.
- Chief Jamie Kessenich from Evansville EMS reported they are doing well and no updates.
- Larry Knuth reports no update from Paratech.

# Hospitals, Clinics, and Health Department

- Jodi Moyer from Beloit Hospital reports their COVID number are going up, but are manageable.
   They will be holding a POD exercise when they do their flu clinic in anticipation for a COVID vaccine POD. Construction is still continuing.
- Dr. Jay MacNeal encouraged everyone to get their influenza vaccinations early this year and will also monitor the progress of the COVID-19 vaccinations. Beth Natter reported that they have begun a paramedic class that is going well.

# **Rock County Public Health**

Alison Chouinard reported employee critical staff numbers received were forwarded on to the state. She also shared the following COVID-19 data numbers: 1,875 cases, 1,565 recovered, 281 active cases, 31,312 negative and 29 deaths. 33% of cases are 18-26 years of age; 10.4% positivity range for the last 14 days; 58% contact tracing reached with 48 hours; and 14 day average daily tests being done are 192 tests. The number of patients reaching care for COVID is trending downward and hospital resources are doing well. She also discussed public health is continuing to work closely with schools.
