Staff Report:

<u>Elder Justice Video:</u> The video was shown which depicts various real-life stories that demonstrate the various types of elder abuse that may occur. It was suggested the video could be used at a congregate "Lunch and Learn."

<u>Annual Caregiver Event:</u> Julie Seeman stated the annual caregiver event, "Art and Relaxation" is scheduled for Thursday, August 25, 2016 at the Welty Environmental Center in Beloit, Wisconsin.

<u>Senior Fairs:</u> Flyers for the Rock County Senior Fair were distributed. Joyce Lubben will e-mail the volunteer sign-up sheet for anyone interested in participating that day.

<u>Purchase of New Transit Bus:</u> Joyce Lubben stated that the County Board of Supervisors approved the purchase of a used bus that will accommodate more ambulatory and wheelchair passengers. This will eliminate the need to use two buses for the same route, thus freeing up a vehicle for other trips.

America Walks Walking College: The Walking College is an interactive, online educational program for walkable community advocates. Molly Nolte was one of 25 Walking College Fellowships awarded throughout the U. S. The fellowship will culminate in a conference in Vancouver, Canada in September where their pedestrian plans will be unveiled.

<u>"Cycling Without Age"</u>: Molly Nolte is in the process of planning a public event regarding "Cycling Without Age," a rickshaw bicycle program designed to allow elderly people who are not able to bike to feel what it's like to ride a bike again. <u>2017 County Budget Request:</u> Joyce Lubben reported she has submitted the 2017 county budget request and it has been reviewed by County Administration. With the exception of the nutrition programs, it is mainly a "cost to continue" budget. She has requested a .4 "health promotion coordinator" to assist with promoting and organizing the health promotion workshops.
