## 1. Call to Order

### 2. Adoption of Agenda

### 5. HOME Program 2017 Activity Report

Director Byrnes presented a program activity report that was submitted by the Wisconsin Partnership for Housing Development (WPHD). The report is appended to the minutes. Items of note were:

- Over \$461,000 of HOME Program funds available for program years 2014 2018
- Contractors are 6 months behind on projects and finding contractors to do the work is becoming difficult.
- \$135,000 committed to loans currently.
- The 55-5-50 Program outreach produced a huge increase in applications, but many were disqualified due to available equity in the homes and various other reasons.

# 6. Rock County Foreclosure of Tax Lien properties and potential Low to Moderate Income Housing Project Fund Matching Requirements.

Kathy Kamp explained what has been done historically regarding the use of Tax Foreclosed properties within the Home Program as they relate to matching funds.

Mr. Byrnes elaborated on the topic and explained how the matching funds work between the Cities of Janesville and Beloit as well as Rock County.

Mr. Byrnes showed the committee photos and street views of several properties that may be good candidates for purchase and rehabilitation should the potential project be allowed by committee and Corporation Council. Mr. Byrnes will discuss with legal and report back to the Housing Committee.

Commissioner Heidenreich moved to adjourn the committee at 9:36 am; Seconded by Commissioner Beaver. **ADOPTED** by acclamation.
