Comments and Update on Draft 2019-2021 County Aging Plan: Julie Seeman provided a summary of the results, so far, from the Council on Aging survey as well as the transportation survey. The agency received 224 responses. The top concerns were: cost and access to food, affordable housing and cost of medications.

<u>Update on Dementia Care Activities:</u> Cori Marsh, Dementia Care Specialist provided an update on dementia activities. <u>ADRC of Rock County:</u> Vicky O'Donnell reported that there are currently about 367 clients on the wait list and the original list had 438 people on it.
