Adult Continuum of Care: Chair Flanagan said efforts continue to focus on the HSD Intake process. It has been implemented with the line being staffed and calls being tracked.

<u>Consumer/Family</u>: Ms. Peterson-Johnson said the Mental Health and Wellness Fair went well. The group is analyzing what went well and what needs improvement for the next event.

<u>Cultural Competency:</u> Vice Chair Deupree said they are working on the connection between this group and the workplace diversity group for Rock County. At the next meeting the group intends to develop a mission statement.

Rock County HSD will contract with them for Peer Specialist services for the Comprehensive Community Services program.

<u>Update on Justice and Mental Health Collaboration Grant Activities</u> Ms. Meboe provided a handout with enrollment numbers, discoveries, and new developments and presented to the group.

<u>Update Regarding AODA Funding through the Rock County Human Services</u>

<u>Department</u> The BHRSC passed a motion to request additional funding from the general fund for this year's Human Services budget to support ongoing treatment funding and to be able to respond to ongoing need for immediate services. The additional funding was approved.

<u>Success Stories/Positive Outcomes Related to Strategic Plan Goals</u> Amy Albert provided a Jail Re-entry client success story to the group.
