### **Staff Report:**

Blizzard Boxes: Ranee Goodroad reported that the blizzard boxes for home delivered meal clients have arrived. We are using a new company this year and the product seems to be improved and is less costly.

Intern: Ranee Goodroad reported that she will be working with a UW-Whitewater social work intern during the spring semester.

Special Events: Ranee Goodroad stated that reservations for the holiday meals are needed well in advance of the holiday as Best Events requires notice to order food.

#### **Old Business:**

Approval for Reduced Hours of Service at Evansville Dining Center: Joyce Lubben reported that the County Board of Supervisors approved a funding mechanism for 2016 that would allow the Creekside Place site to remain open two days per week provided Creekside is willing to host the

site rent-free. They also requested the site be evaluated after one year. They also stipulated that there be no home delivered meal waiting lists. If the Council on Aging's budget is not sufficient to cover the cost of all home delivered meals the budget will be amended using the County's contingency fund. A motion was made by Supervisor Norvain Pleasant, seconded by Nancy Arnold, to approve the reduction in hours at Creekside Place to two days per week. Motion carried.
