- 2. **Approval of Agenda:** Supervisor Davis moved to approve the agenda as presented, seconded by Supervisor Driscoll. **Motion Carried.**
- 3. **Approval of Minutes February 1, 2017:** Supervisor Zajac moved to approve the minutes of the February 1, 2017 Land Conservation Committee meeting, seconded by Supervisor Hawes. **Motion Carried.**
- 4. **Citizen Participation, Communications, and Announcements:** Supervisor Davis noted he attended the Agriculture Community Engagement meeting held in Wisconsin Dells February 21, 2017. High Capacity wells and Animal Waste was the highlights of the meeting. Discovery Farms will hold a meeting on March 23<sup>rd</sup> regarding Nitrates in Groundwater. Tom Sweeney noted the Andrew Farm is in Compliance with the standards for FPP but requested to be removed from the program. Supervisor Sweeney expressed concern. No further discussion. **Motion Carried.**
