- 2. **Approval of Agenda:** Supervisor Owens moved to approve the agenda as is, seconded by Supervisor Davis. **Motion Carried.**
- 3. **Approval of Minutes October 13, 2015:** Supervisor Davis moved to approve the minutes of the October 13, 2015 Land Conservation Committee meeting, seconded by Supervisor Zajac. **Motion Carried.**

- 7. **Purchase of Agriculture Conservation Easements (PACE) Program Update**: No updates at this time.
- 8. Conservation Reserve Enhancement Program (CREP) Approval of Agreements:
 Supervisor Rebout moved to approve the CREP agreements, seconded by Supervisor Davis.

- 9. **Farmland Preservation Program (FPP) Approval of Voluntary Program Withdraws**: Some discussion followed. Supervisor Rebout suggested that Janesville Township landowners in FPP that have had land excluded in the 2015 Farmland Preservation zoning district update should contact the Township to see if their parcels may be included with map revisions. Supervisor Rebout suggested we call Al Condon to advise him to contact his Township. Supervisor Rebout moved to table the non-compliance at this time for Condon Family Trust, seconded by Supervisor Davis. **Motion Carried.**
