Administrative Division

Approval of Bills/Transfer of Funds/ Pre-Approved Encumbrance

Dr. Konkol and Ms. Wade made a motion to approve the bills for June 2015. There were no questions on the bills, MOTION APPROVED.

Ms. Wade and Dr. Konkol made a motion to approve the transfer of funds for June 2015. MOTION APPROVED.

Chair Kraft inquired how many computers were purchased as a result of the transfer. Health Officer Sandoval stated that one computer was purchased.

Health Department Report

Health Officer Sandoval announced the resignation the Administrative Secretary effective 7/10/15. The job will be posted July 1, 2015-July 7, 2015. All tasks have been delegated to other staff members during the interim. Health Officer Sandoval introduced the two Health Department interns: Corey Janssen-AHEC intern and Claire Hahn-Health Department Intern. Corey is working on surveys for hand washing and water testing. Claire will be working on a "get immunized" campaign.

Health Officer Sandoval announced that we received two confirmed pertussis cases since the last Board of Health Meeting. The Health Department sent one bird to the Wisconsin State Lab of Hygiene for West Nile Virus. The bird tested negative.

A fire occurred at a Rock County Hotel which resulted in 37 people placed in temporary housing by Emergency Management. The Health Department inspected the hotel the next day and discovered several violations. The owner of the facility had until 6/30/15 to correct violations and has requested additional time.

Health Officer Sandoval provided the following budget updates:

- The pre-budget meeting is July 13, 2015
- Budget projections are being made at three points: cost to continue, proposed decrease, and proposed increase.
- Collaboration and strategic planning ideas will be submitted in addition to the budget.

Environmental Health

Public Health Nursing

Public Health Nurses, Valerie Christensen and Casey Stubbs , presented to the Board of Health on Community and Public Health Referral Collaboration with Early Head Start.

Dr. Peterson inquired how the Health Department receives referrals. Casey Stubbs, RN stated that referrals come from a variety of sources including: Stateline Pregnancy Service, medical providers, birth certificates, word of mouth, and Head Start. The referrals between Early Head Start and the Rock County Health Department reciprocal.
