## <u>Resolution – Requesting The Board Of Health To Investigate Options For Dental Services For Low-Income</u> <u>Residents Of Rock County And Report To The County Board</u>

NOW, THEREFORE, BE IT RESOLVED by the Rock County Board of Supervisors duly assembled this 15<sup>th</sup> day of December, 2016 that they request the Board of Health to do the following:

- 1) Gather information on existing County programs in Wisconsin that are helping those residents that are at or below 200% of the federal poverty line obtain appropriate dental care.
- 2) Review and develop strategies that have effective cost containment to assist local residents to obtain dental care.

- 3) Create a plan to assist low-income residents of Rock County in obtaining dental services including partnering with local agencies such as Blackhawk Technical College.
- 4) Develop a committee of community leaders to come up with strategies to help provide dental services to low-income County residents.
- 5) Lobby the state legislature to improve reimbursement rates to providers offering dental services to low-income County residents and ask that Rock County be included in the State dental pilot program.

BE IT FURTHER RESOLVED, that the Board of Health shall report back their findings and proposed plan to the County Board at the February 23, 2017 County Board meeting.

Dr. Konkol made a motion to approve the resolution. Supervisor Bostwick seconded the motion. MOTION APPROVED.

- Why Fluoridation is Important
  - Least expensive and most effective way to reduce tooth decay
    - Reduces tooth decay by 25% in children and adults (CDC, 2016)
  - o Reduces the need for dental treatment and its costs
    - Health benefits of fluoride include:
      - Fewer cavities
      - Less severe cavities
      - Less need for fillings and tooth removal
      - Less pain and suffering because of tooth decay
  - Rock County Water Fluoridation

  - Head Start Fluoride Varnish Program
    - Provided by Rock-Walworth Comprehensive Family Services

    - In Head Start, 97% received dental exams and 96% received fluoride treatment.

The Board members discussed water fluoridation and methods of fluoride delivery. They also discussed dental school enrollment and providers that accept BadgerCare.

Ms. Klingensmith gave a PowerPoint presentation for the Board: Health Equity Alliance of Rock County (HEAR)

- Overview
  - Who: HEAR is a multisector collaboration, that includes local residents and organizational representatives, that live and work in Rock County.
  - o What: The HEAR group works to identify community needs and create strategies to improve the health of Rock County.
  - $\circ$  When: Second Wednesday of the month from 10:30 am 12:00pm
  - O Where: Southern Wisconsin Regional Airport
  - o Why: Shared ownership of community health, through broad and diverse community engagement, has been shown to improve the health of communities.
- Background
  - 2010 CHNA group formed to fulfill Federal requirement stating:
    - "Non-for-Profit Hospital's must conduct a community health needs assessment (CHNA) at least once every 3 years."
  - o 2012 Transform Rock County grant
  - o Focus areas:
  - o 1) Reduce exposure to secondhand smoke in multi-unit housing
  - o 2) Improve school nutrition for children
  - o 3) Increase opportunities for physical activity in our communities
  - o 2014 Transform Grant ended due to a loss of funding from the CDC
  - o 2015 CHNA group requests RCPHD create a position to lead the group
  - O June 2016 Community Health Education Coordinator hired

  - Many of the issues currently facing Rock County may have similar underlying causes(e.g. lack of education or lack of health motivation) and we may be able to have a greater impact in some of those areas if we address the underlying causes rather than issues themselves.

  - o January 15, 2017- March 1, 2017 Community Health Assessment
  - o Mailed 2,000 random Rock County residents
  - Option to answer survey via mail or online

  - O Spanish survey will be mailed per request & available online
  - o 598 surveys need to be completed

Supervisor Garrett asked how Ms. Klingensmith determined the number of surveys that needed to be completed. Ms. Klingensmith replied that DHS provided a statistical calculator for representative samples. Conversation followed about capturing information from minority and special interest groups. Ms. Sandoval added that Ms. Klingensmith was able to keep the budget to \$1900-\$2000 and received donations from the other partners in the amount of \$1950. Other Health Departments had budgets averaging \$3000.

Supervisor Kraft introduced Supervisor Schulz who is the originator of the resolution. Ms. Schulz stated that the purpose of the resolution is to help HealthNet get more funding, help veterans, help people exiting jail get services, help children not able to access enough dental programs, and help foster parents obtain services for foster children. HealthNet has taken BadgerCare, unemployed, and uninsured clients. The Board members discussed non-monetary resources. Supervisor

Schulz said she is hoping that the Public Health Department and the Board of Health will take a look at other surrounding communities and find out how they are able to get people to go in for services more regularly. She stated that other counties don't have a lot of money and have done some creative things. The Board members had a discussion about dental providers accepting BadgerCare. More discussion followed regarding dental health education. Mr. Gresens asked if this can fit in with what the Public Health Department is already doing. Ms. Sandoval stated that they are already doing a lot of these things. It is part of the Public Health Department's strategic plan and has already been identified as a priority. More discussion about education and awareness followed.

Supervisor Peer made a motion to table the resolution indefinitely. Mr. Gresens seconded the motion. MOTION APPROVED.

Supervisor Schulz asked if there were some things in the resolution that can be looked at and worked on. Supervisor Garrett replied that the wording of the resolution is problematic. People need to be able to understand what it means to the county. She suggested a resolution that promotes February as dental health month. Dr. Winter suggested an article in the newspaper that lists services available to correspond with dental health month. Supervisor Schulz said she is open to taking another look.

## **Review of Payments**

The Board reviewed the Health Department's bills for the month of December in the amount of \$13,600.87.

### **Health Department Report**

Ms. Sandoval introduced Matt Wesson as the new Environmental Health supervisor. He has been with the Public Health Department since 2002. He wants to finish his career in public health and is excited with the direction that the Rock County Public Health Department is going.

### Surveillance

According to Ms. Sandoval there have been six cases of varicella confirmed at an elementary school. There is also a suspected case of norovirus.

Ms. Sandoval reported that influenza hospitalizations have been down. There were 99 hospitalizations in 2015 and 48 in 2016.

### Community Events / Outreach

Ms. Sandoval thanked the Board members for judging the art contest last month.

#### Strategic Planning

Ms. Sandoval stated that they are putting the pieces together and will report on the strategic planning next month.

#### Budget

According to Ms. Sandoval, the Public Health Department received a \$12,000 refund for two years of overcharges from their liability insurance company.

#### Personnel

Ms. Sandoval announced that she will be posting the open Environmental Health positions next week.

Supervisor Garrett made a motion to adjourn the meeting. Dr. Konkol seconded the motion. MOTION APPROVED. Meeting adjourned at 7:43 p.m.
