

MINUTES OF BOARD OF HEALTH MEETING

July 6, 2016

Meeting was called to order by Chair Kraft at 6:00 p.m.

Adopt Agenda

Supervisor Bostwick made a motion to adopt the agenda. Ms. Wade seconded the motion. MOTION APPROVED.

Approval of Minutes – 6/1/16

Supervisor Garrett made a motion to approve the minutes of the 6/1/16 Board of Health meeting. Ms. Wade seconded the motion. MOTION APPROVED.

Citizen Participation

Ms. Castrucci, Ms. Klingensmith, and Mr. Good introduced themselves and told the Board members about their duties at the Health Department.

New Business

Administrative Division

Review of Bills/Transfer of Funds

The Board reviewed the Health Department's Committee Review Report for the month of May 2016 and the list of bills provided by the Health Department. Chair Kraft asked about the charge for polo shirts on the list of bills. Ms. Erickson replied that there was money left over when polo shirts were ordered previously, so there was another order placed. Supervisor Garrett asked when the Health Department employees wear the polo shirts. Ms. Erickson replied that they are worn at events and when the Health Department is out in the public. The shirts help identify them as Health Department employees.

Health Department Report

In the News

Elizabethkingia: Mr. Banwell relayed to the Board that there have been 63 cases of Elizabethkingia in 12 counties throughout Wisconsin. There has also been one case in Michigan and two cases in Illinois. The Health Department receives updates every other week.

Zika: Mr. Banwell reported that there have been two cases of the Zika virus in Wisconsin. Both cases were contracted outside the United States. The Health Department is participating in a study to monitor the types of mosquitos in Wisconsin. Twenty traps are placed around Rock County and the mosquito eggs are sent to the state for evaluation. The Board members discussed what types of mosquito repellants are available. Mr. Banwell added that standing water is the best breeding ground for mosquitos.

Surveillance

Ms. Erickson reported that there has been an upswing in pertussis cases in Rock County. There have been five cases in the last two weeks. Supervisor Garrett asked about the procedures for reportable diseases. Ms. Erickson reviewed the requirements and procedures for reportable diseases.

Strategic Planning

Mr. Banwell stated that the Health Department is continuing to work on the strategic planning process.

Budget

The pre-budget meeting for the Health Department took place on June 13th. Mr. Banwell said that the resolutions included in the agenda were originally part of the pre-budget packet, but are being acted on now because they are budget neutral or have not budget impact.

Personnel

Mr. Banwell and Ms. Erickson reported that there have been some changes to the Health Department staff. Ms. Klingensmith began her position as Community Health Education Coordinator on June 6th and Faith Olsen resigned her Public Health Nurse position on June 23rd.

Several Public Health Nurse positions have already been posted with an open end date. The Health Department has not received many applicants for this position. The existing Public Health Nurses are being encouraged to talk to friends and the position has been posted on the Health Department Facebook page in order to get the word out. The posting has also been added to the WPHA job listings.

One Public Health Nurse position is being understaffed with a Health Educator. This position has been posted and will close mid-July.

The Health Department has also posted a .4 FTE PHSS position on 6/29/16. This position will also close mid-July. There is a vacant PHSS position that has not been filled since the former employee left in December. The part-time employee is needed to cover phones and fill-in where needed.

Chair Kraft asked if the rest of the Health Department is aware of the upcoming changes in staff. Mr. Banwell replied that the information was shared at the most recent staff meeting.

Mr. Banwell informed the Board that the overlap will allow him to train a new director before his retirement.

Supervisor Peer made a motion to approve the resolution. Ms. Wade seconded the motion. MOTION APPROVED.

Resolution – To Create The Position Of Environmental Health Supervisor, Create A Class Description And Establish A Pay Range

NOW, THEREFORE, BE IT RESOLVED that the Rock County Board of Supervisors duly assembled this _____ day of _____, 2016 moves to delete 1.0 FTE Public Health Nurse position and create the position of a 1.0 FTE Environmental Health Supervisor, create the class description, and establish Pay Range 25 (\$62,744.40-\$76,170.24).

Mr. Banwell explained that the supervisor position will be involved in the permit renewals, new facilities, and inspections for the public licensing programs. The position will also coordinate training and keep records. This will allow the Environmental Director to be more involved in policy making and state level interaction.

Supervisor Bostwick made a motion to approve the resolution. Ms. Wade seconded the motion. MOTION APPROVED.

Resolution – Accepting South Central Healthcare Coalition (SCHCC) Micro-grant Award Fund Adjustment and Amending the 2016 Rock County Public Health Department Budget

Childhood Lead Poisoning Prevention

- Comprehensive lead poisoning prevention laws and statutes
- Steep decline from 88.2% (1976-1980) to 0.9% (2003-2008) of children aged 1-5 with blood lead levels >10 mcg/dl
- Risks based on socioeconomic status and race were reduced significantly
- Economic savings estimated at \$213 billion per year
- Rock County Public Health Department focus
 - o Reported elevated lead
 - \sim 2007 32 over 10 mcg/dl
 - \sim 2008 45 over 10 mcg/dl
 - \sim 2009 53 over 10 mcg/dl
 - 2010 40 over 10 mcg/dl
 - \sim 2011 58 over 10 mcg/dl
 - 2012 27 over 10 mcg/dl; 58 5-9 mcg/dl

- 2013 27 over 10 mcg/dl; 119 5-9 mcg/dl
- 2014 25 over 10 mcg/dl; 110 5-9 mcg/dl

Public Health Preparedness and Response

- Laboratory, epidemiology, surveillance, and response capabilities
- Ability to develop and implement a coordinated public health response
 - o Rapid detection and characterization of the outbreak
 - o Deployment of lab tests
 - o Distribution of PPE from strategic national stockpile
 - o Development of a vaccine
 - o Widespread administration of the vaccine
 - o 5-10 million cases, 30,000 hospitalizations, and 1,500 deaths (2009 H1N1)
- Rock County Public Health Department focus
 - o Department wide training
 - o Exercises
 - Mass clinics
