BEST MANAGEMENT PRACTICES

Groundwater Nitrate Work Group

August 27, 2018

The following Best Management Practices are being recommended by the Groundwater Nitrate Workgroup to the Agricultural and Extension Committee to be included in the 2019 County Farm Lease.

Nutrient Management (NRCS 590, published 2015):

The source, rate, timing and method of application for all major nutrients — nitrogen (N), phosphorus (P2O5), and potassium (K2O) shall be accounted for and shall be consistent with the most current edition of UWEX A2809 recommendations.

Nitrogen Application Timing – The goal of timing nitrogen (N) applications to corn is to supply adequate N when the crop needs it, without supplying excess that can potentially be lost. Applying N at multiple times, including the time of maximum crop uptake, can spread the risk of N loss and crop deficiency, improve profitability by reducing N rates, and benefit the environment.

Cover Crops:

Grasses, small grains, legumes, forbs, and/or other herbaceous plants established for seasonal cover and conservation purposes, specific to reducing nitrogen leaching to groundwater.

Conservation Tillage:

AKA Reduced Till: Managing the amount, orientation, and distribution of crop and other plant residue on the soil surface year round while limiting the soil-disturbing activities used to grow and harvest crops in systems where the entire field surface is tilled prior to planting. Minimum 30% residue post planting.

Nitrification Inhibitor:

A compound that temporarily blocks the activity of nitrifying bacteria and limits the conversion of ammonium to nitrate. Use of a nitrification inhibitor with ammonium based fertilizers or manure has the potential to reduce nitrate loss via leaching or denitrification. Follow product label.
