BE IT FURTHER RESOLVED, that the Chair shall appoint up to six citizen members to two-year terms, and up to five citizen members to three-year terms. Subsequent appointments shall be for three years.

BE IT FURTHER RESOLVED, that the Chair shall appoint a member of the Steering Committee to serve as a temporary chair until such time that the Committee establishes a method for electing and elects a chair from its membership."

Supervisor Kraft moved approval of the above resolution, second by Supervisor Brill. ADOPTED.

Mr. Deupree, Chair of The Justice & Mental Health Ad Hoc Committee, asked for the support of this resolution and explained the importance and purpose of the Behavioral Health Redesign Steering Committee.

Consider and Take Possible Action on Elected Officials Salaries.

Chair Podzilni read a letter from Mr. Randy Leyes, Register of Deeds, stating that he is not looking for an increase. Ms. Stottler, County Clerk, stated that Ms. Vicki Brown,

County Treasurer, was unable to attend, but that the three of them (Ms. Stottler, Mr. Leyes and Ms. Brown) are not looking for an increase, nor a decrease. She stated that their take home money is going down and she is here to just listen.

Mr. O'Connell went over documents showing the elected officials salaries from 2007 to 2014, along with the staff (employees covered by union contracts and unilaterals) and our counterparts throughout the state for other counties in Wisconsin.

Supervisor Kraft suggested the following proposals:

- 2013 0%
- 2014 1%
- 2015 1.5%
- 2016 2%

Elected Officials would be responsible for paying their portion into the Wisconsin Retirement System along with participating in the wellness program as part of the health insurance offered by Rock County.

Chair Podzilni stated a resolution will be on the agenda for County Board Staff on Tuesday, March 5, 2012.

Executive Session: Supervisors Arnold and Yankee moved to go into Executive Session at 4:30 P.M. per Section 19.85(1)(g) Wis. Stats — To Confer with Legal Counsel Regarding Potential Litigation. ADOPTED on a roll call vote with the following: Ayes — Supervisors Arnold, Brill, Kraft, Peer, Podzilni, and Yankee; Supervisors Bussie, Collins and Jensen absent.

Chair Podzilni announced that the Committee would meet in closed session to Confer with Legal Counsel Regarding Potential Litigation as authorized by Section 19.85(1)(g) of the Wisconsin Statues.

Supervisor Yankee moved to go out of Executive Session at 4:50 P.M., second by Supervisor Brill. ADOPTED.

<u>Adjournment</u>. Supervisor Arnold moved adjournment at 4:50 P.M., second by Supervisor Peer. ADOPTED.
