Supervisor Jensen moved approval of the above resolution, second by Supervisor Kraft. ADOPTED.

Approval of Administrative Policy and Procedure Manual Changes. Mr. O'Connell said the first policy to go over is "Work Situations (Atypical)", Policy number 5.52. Mr. Knutson said these "project" employees are funded by some type of grant and have no specified end date. Mr. O'Connell added they are hired with this understanding that when the funds run out they are done. Mr. Knutson said they would be mostly represented positions but would have no bumping rights.

Supervisor Jensen said on the second page, under Volunteers, second sentence the word "of" should be deleted, and "out-of-pocket" should not be hyphenated.

Mr. O'Connell said the next policy to go over is the "Smoking Regulation", Policy number 5.39. He said the change to this policy is to comply with the ordinance.

Mr. O'Connell said the last policy to go over is "Overtime, Flex and After Hours", Policy number 5.31. He said this is for areas with 24 hour service and the Division Managers would be paid a stipend based on their salary.

Supervisor Bussie moved approval of the Administrative Policy and Procedure Manual changes, second by Supervisor Mawhinney. ADOPTED.
