## **AIRPORT BUSINESS**

Approve Resolution Authorizing Easement to Alliant Energy. Supervisors Fox and Bussie moved the resolution. This resolution gives Alliant Energy an easement to relocate the gas line from the safety area of the Airport. It will be located on the south side property line. MOTION CARRIED.

<u>Discuss/Action-Request from Matt Kealy Regarding Utility Bills.</u> Matt Kealy discussed his request with the Committee. The invoice lists the different square footages he was responsible for during recent construction. He is requesting a credit of \$951.23 for utilities. Discussion. Supervisors Fox and Bussie moved to agree with Matt's request for a \$951.23 credit and that the final bill use the 12.12% figure. Ron Burdick agrees with the Committee motion. Mr. Kealy plans to vacate the airport terminal building on April 30, 2013. MOTION CARRIED.

<u>Airport Accounts Receivables.</u> Ron distributed the report. FabTech is not up-to-date with their payment and Ron will be talking to Corporation Counsel about that.

<u>FAA Closure of Contract Control Tower.</u> Ron stated the tower will be closing May 5, 2013. To fund the tower, it would cost the County \$500,000 annually. Discussion on local funding took place. Liability issues were also discussed. Mr. Arrowood stated the company he works for is willing to discuss options available and will give Ron their phone number. Mr. Arrowood stated on a busy weekend, the tower handles 30-50 operations an hour. With Kealy's Café closing, there will be less traffic.

<u>Project Updates: Terminal Expansion Project #2.</u> The bid ad for phase II should be in the paper today. Bid options were discussed.
