1. **Call to Order:** Chair Bostwick called the meeting of the Land Conservation Committee to order at 7:15 p.m.

- 8. **Approval of 2012 Clean Sweep Contract.** Supervisor Wiedenfeld motioned to approve the contract as presented, seconded by Supervisor Combs. Tom Sweeney explained that the 2012 contract with DATCP has been reduced by approximately \$5,000 from last years contract. **Motion Carried.**
- 9. **Erosion Control and Storm Water Management Request for Permit Extension Rock Prairie Dairy Project**. Supervisor Arnold motioned to approve the extension request as presented, seconded by Supervisor Sweeney. Tom Sweeney explained that the construction project was set back by in climate weather in the spring and the excavation contractor was unable to complete the construction of the Storm Water Management Systems prior to the established cut off date. The site has been stabilized until weather permits completion in the spring. **Motion Carried.**
- 10. Purchase of Development Rights. This item was skipped due to lack of business.
- 11. **Department Update:** Tom Sweeney provided an update on Department activities since the last LCC Meeting.
- 12. **Adjourn:** Supervisor Arnold motioned to adjourn the January 4, 2011 Land Conservation Committee meeting at 8:10 p.m., seconded by Supervisor Wiedenfeld. **Motion Carried.**
