ROCK COUNTY HUMAN SERVICES BOARD MEETING Wednesday, August 26, 2020 – 4:30 P.M.

<u>Call to Order</u>: Chair Knudson called the virtual meeting to order at 4:30 p.m. on Wednesday, August 26, 2020.

<u>Approval of Agenda</u>: Citizen Representative Weaver-Landers moved the agenda to the floor, seconded by Supervisor Podzilni. The agenda was unanimously approved. APPROVED.

Approval of Minutes of Human Services Board Meeting of August 12, 2020: Supervisor Bostwick moved the minutes to the floor, seconded by Citizen Representative Kleven. The minutes were unanimously approved. APPROVED.

Citizen Participation, Communications and Announcements: None.

<u>Submission of Committee Requests</u>: Supervisor Schulz requested information about what is being done to help people who are getting evicted. Supervisor Williams asked about the suicide rates for Rock County and how things are going in that area.

<u>Approval of Contracts and Transfers</u>: Citizen Representative Weaver-Landers moved two contracts to the floor, seconded by Supervisor Williams. Ms. Mooren provided information about each of the contracts. The contracts were unanimously approved. APPROVED.

Rock County Human Services July Employee Impact Award: Ms. Luster introduced Kristen Kath the recipient of the July Employee Impact award. Ms. Kath is a lead worker in the Children's Long Term Support program. Ms. Luster read the nomination which expressed how Ms. Kath is an amazing co-worker and also for her inclusivity and overall positive energy. She is always doing more than what is required of her, often staying late, starting early, or scheduling meetings on her day off, whatever it takes to meet the needs of her families. She reached out to co-workers even if they were not in her unit to ensure they were doing well and feeling connected during this challenging time.

Rock County Human Services August Employee Impact Award: Ms. Luster introduced Meghan Pulgarin. Ms. Pulgarin is an Administrative Assistant for the CCS program. Ms. Luster explained Ms. Pulgarin received three nominations and Ms. Luster highlighted points from nomination which expressed how Ms. Pulgarin goes above and beyond helping workers with day to day functions and procuring PPE. She even offered to come in on a holiday to pick up a shipment. She is consistently even keeled, warm and positive. She has been instrumental with assisting with sending out family therapy resources to families. Her personal touch is appreciated not only by the workers but by the families which are served.

Resolution to Recognize Georgia Waterman: Citizen Representative Kleven moved the resolution to the floor, seconded by Citizen Representative Weaver-Landers. Ms. Trimble introduced Georgia Waterman. Ms. Waterman has served the citizens of Rock County for forty six years as a dedicated and valued employee of Rock County. She began her career in 1974 as a Certified Occupational Therapy Assistant for HSD serving clients at multiple locations. In 2010, she moved into the role of Psychiatric Technician in Crisis Intervention where she has served in a multifaceted capacity to support the crisis intervention unit. She is regarded by many as a dedicated and compassionate presence who will be greatly missed by all. The resolution was unanimously approved. APPROVED.

Resolution Amending the 2020 HSD Budget to Accept Supplemental Funding for the Coordinated Services Teams (CST) Initiative: Citizen Representative Weaver-Landers moved the resolution to the floor, seconded by Supervisor Bostwick. Chair Knudson asked for a friendly amendment to make a change from \$8,000 to \$7,200 on line 14. Ms. Singer presented the resolution and explained Coordinated Services Teams (CST) is a program to provide wrap around care for families and support to keep children in the community. She explained how the funding will be utilized. The resolution with the change was unanimously approved. APPROVED.

Resolution Reclassification of 1.0 FTE Account Clerk II Position to Account Clerk - HSD: Citizen Representative Weaver-Landers moved the resolution to the floor, seconded by Citizen Representative Kleven. Ms. Mooren presented the resolution and explained that the Account Clerk II position is currently vacant but will be performing similar general accounting duties as other Account Clerk-HSD positions and will provide coverage for each other. When hired this position will primarily be providing account support for CLTS which is continuing to grow. The resolution was unanimously approved. APPROVED.

Approval to Award Wisconsin Home Energy Assistance Program (WHEAP) to Energy Services: Citizen Representative Weaver-Landers moved the resolution to the floor, seconded by Supervisor Williams. Ms. Mooren presented the resolution and explained Rock County HSD issued an RFP for the WHEAP. One agency, Energy Services, submitted a bid and was rated. Energy Services has a long history providing these services with Rock County and will continue. The contract will start October 1, 2020. The resolution was unanimously approved. APPROVED.

Director's Report:

• **Department Operations and Return to Work Planning:** Ms. Luster advised most HSD staff are continuing to work remotely at this time. HSD has been managing staff who have tested positive and have been collaborating with Public Health Department. These cases have provided strong evidence in support of continuing promoting working remotely. Limiting staff working in the office has made a big difference in limiting exposure to other staff and clients.

HSD has gathered information to confirm hazard pay for higher risk employees. HSD is grateful for the support and recognition from the County Board to receive hazard pay.

- HSD 2021 Proposed Budget Updates: Ms. Luster advised that HSD requested a 1.55% increase above last year's budget request. She explained some things have been put on hold and HSD wants to be realistic about what is ahead. There are a lot of unknowns with the move to 1717 and with COVID-19 in general. HSD is doing the best possible even with the unknowns. Ms. Luster shared a power point presentation and reviewed strategic priorities and other highlights. She advised since the pre-budget information was shared previously HSD has added an Equity and Engagement position. This will be a leadership position who will be a member of the HSD Integrated Management team (IMT), and will work across all the HSD departments prioritizing equity, anti-racism and inclusion. HSD meets with County Administrator Smith in September about the HSD Budget request. She advised the HSD Board will be voting on the 2021 HSD Budget at the October 9, 2020 HSD Board meeting.
- Response to Covid-19 Related Community Needs: Ms. Luster advised HSD is being responsive to community needs. She informed that Community Action is no longer taking housing applications. HSD is promoting housing for clients and is working on an internal process and criteria for housing support funds. At the Behavioral Health Redesign Steering Committee (BHRSC) there has been discussion about getting information out in Spanish for housing funding and HSD services in general. Alliant Energy is not cutting off services at this time. Return to school is a focus for parents both with the community and for staff. HSD is trying to be as flexible as possible. Ms. Luster responded to questions about virtual schooling and technology.

Executive Summary

Amending the 2020 Human Services Department Budget to Accept Parents Supporting Parents Grant Funds and Creating 2.0 FTE Family Well-Being Coordinator Positions

Rock County Human Services Department was recently awarded a three-year grant from the Wisconsin Department of Children and Families to be one of three Innovation Zones in Wisconsin to implement a Parents Supporting Parents Program. (Implementation is occurring later in 2020 than planned due to delayed notification from DCF about the ability to award these funds to Rock County). The Parents Supporting Parents Program is an evidence-based model that is aimed at empowering parents with lived-experience as clients of Child Protective Services. Experience to serve as mentors to parents currently within the child welfare system. The program simultaneously aims to integrate the voice of lived experience into the Wisconsin child welfare system at large. Experience with similar programs reported both tangible and intangible benefits including a higher percentage of family reunifications and a lower percentage of subsequent child removals; parents experiencing greater belief in themselves; improved knowledge of how to advocate for themselves; organizational skills; and improved access to resources.

The grant funding will be utilized to implement the Parents Supporting Parents program here in Rock County. Staffing to support this effort will include the creation of one full-time Family Well-Being Coordinator in the planning year and an additional Family Well-Being Coordinator position in year 2021. We will also create an equivalent of 10 FTE of full and part-time Family Well-Being Specialist positions in 2021 and 2022. In addition, funding will be used to contract with a clinical support provider(s), to attend trainings, and for other overhead expenses. The Family Well-Being Coordinator will require a Bachelor's Degree and ideally have professional experience with the child welfare system and will provide training to their team of Family Well-Being Specialists, arrange for Clinical Support, provide oversight of day-to-day tasks of the program, and coordinate case management and provide individual supervision on cases.

The total award of the grant is for \$1,021,590 over three years The payment schedule for this grant is \$78,540 in the planning year (2020), \$370,100 in year one (2021) and \$572,950 in year two (2022). After this contract period, Innovation Zones may be eligible for up to four annual contract renewals for full implementation of the program at reduced funding levels (2023 and beyond). Thereafter, these positions will be sustained through cost savings of returning children to their home, utilizing child welfare allocation, combining efforts with another county or counties, and/or Medicaid funding through the Comprehensive Community Services program.

Executive Summary

Creating 5.0 FTE Positions to Support Project Implementation and Supportive Services to Enhance the Safety, Permanence, and Well-Being of the Children and Families Being Served in Child Protective Services

Rock County Human Services Department received additional \$1.15 Million in funding from the Wisconsin Department of Children and Families in the 2020 budget. These additional funds were allocated to support incentive pay for child welfare staff, consultation services for program development, to reduce the tax levy allocated for out of home placement costs, to add staff resources for quality improvement efforts, and to support increased in-home safety services for families. A portion of the funding remained undesignated and was budgeted in contracted services pending further planning and program development decisions. This resolution proposes to utilize \$91,370 from the previously undesignated funds to increase staff to support and advance program development efforts.

A priority in the Child Protective Services area is to assure that our practice is increasingly aligned with the evidence of what is most effective in assuring positive outcomes for the children and families that we serve. In addition, significant changes in Child Welfare practice are occurring as a result of the Federal Family First Act, landmark legislation that changes the way that federal IV-E funding can be utilized and requires additional efforts and resources to prevent out of home/out of family placements for children. In response to these priority areas, the Human Services Department plans to utilize increase staffing resources to support these system and practice changes. Requested staff include one full-time Coordinator of Family Support to support implementation of the Parents Supporting Parents Grant, Development/Implementation of Family Team Meetings, and duties to support the Program Manager, Supervisory Staff, and CPS Staff. In addition, we will create two fulltime Family Team Meeting Coordinators and two full-time Case Aide Positions. The Family Team Meeting Coordinators will focus on strengthening a process for team meetings across the CPS system as well as facilitate the meetings across the life of a case. Case Aides will be assisting CPS staff in supportive functions such as documentation, UA's, printing/mailing letters, coordination phone calls, and other tasks. The addition of these positions will enable the HSD to commit to enhanced program development without adding these responsibilities to staff who are already dealing with maximized workloads.
