Equipment Donation to Wellness Workout Center

The County's Wellness Workout Center continues to be used primarily by Health Care Center staff. With the completion of the HCC security system project later this year, it is anticipated that the Workout Center will be highly popular.

Per county policy, donated equipment can be accepted by the County upon formal approval of the County Board Staff Committee.

Several county staff have requested to donate the following equipment to the Workout Center. The equipment would be added to, or replace existing equipment:

- 1. Stairmaster donated by Barb Meister, Sheriff's Office
- 2. Treadmill donated by Barb Meister, Sheriff's Office
- 3. Bow flex donated by Barb Meister, Sheriff's Office
- 4. Stationary bike donated by Barb Meister, Sheriff's Office
- 5. Pull up tower donated by Bob Crandall, HSD
- 6. Workout bench donated by Steve Miller, HSD

The employees acknowledge that the donated equipment would be placed at the Workout Center for use by all employees; becomes the property of the County and could not be removed if he/she were to leave the County.

Sufficient space is available to accommodate the six pieces of equipment requests and is being recommended by the Wellness Committee.

On a related note, the County Wellness Committee purchased an off-new elliptical machine for \$1,750 and will be replacing an older model. In addition, the County has been approached on a donation of a punching bag but could not accept as we would need to address blood-borne pathogen concerns.
