1. **Call to Order:** Chair Bostwick called the meeting to order at 7:00 pm.

Committee Members Present: Stephanie Aegerter, Rich Bostwick, Wes Davis, Kaelyb Lokrantz, Mike Mulligan, James Quade, Alan Sweeney and Jeremy Zajac.

Committee Members Excused: NONE

Others Present: Tom Sweeney, LCD; Chris Murphy, LCD; Chris Newberry, LCD Randolph Terronez, County Administration, Tom Brien, County Board Member and Kara Purviance, County Board Chair.

- 2. **Approval of Agenda:** Supervisor Mulligan moved to approve the agenda as presented, seconded by Supervisor Davis. **Motion Carried.**
- 3. Election of Committee Vice-Chair: Chair Bostwick asked for LCC vice Chair Nominations. Supervisor Quade nominated Supervisor Sweeney for Vice Chair, which was seconded by Supervisor Davis. To the Rock County Land Conservation Committee,

MS Properties of Rock County is the owner of the property at 5705 N Milton-Shopiere Rd, Milton WI as of October 4, 2019. In the months following the purchase of this property some work was done on the property to prepare the site for the addition of a new shop building to the property. When the excavation work was done by Frank Silha & Sons Excavating, I was unaware that some of the area we were working in was part of the storm water area and thus I would need an Erosion Control & Storm Water Management Permit to complete the work. This property is a gravel pit and the entire property is zoned as such. The mining area is only approximately 500 feet away from the area disturbed and of course has no storm water management rules to follow. Given these facts, I thought the area disturbed would be exempt from the need for a permit as well.

It was brought to our attention when a Land Conservation employee visited the property that this particular area of the property was considered part of the storm water area. Since then we have worked with Combs & Associates to revise the plans for the area to meet the Land Conservation specifications. The new plan, with the exception of 800 SF more Bio Basin Area, is no different than the previous plan. I have also paid \$1,535 in fines for the work that was previously performed. When the application for the permit was submitted the Land Conservation staff had charged the double permit fee according to sections 4.809 and 4.1109 of the County Ordinance, before they would process the application. In an effort to keep the construction project moving forward, I have paid the double fee. I am requesting that the Rock County Land Conservation Committee consider refunding the double fee due to the situation and that I acted in good faith and did not intentionally violate any Ordinances. The work that was performed did not cause any erosion/silt to leave the site. I have complied with all requests and paid all fines since it was brought to my attention that a permit was required. The amount of the request is \$1,601.50.

WHEREAS, the level of nitrates in Rock County's groundwater has increased over the past two decades
in private and public wells, with over 30% of the county wells exceeding the drinking water nitrate health
advisory of 10 mg/L; and,

6 County Board meeting establishing a workgroup composed of the following representatives, Public

EXECUTIVE SUMMARY

This resolution requests County Board approval to extend the deadline for the established Groundwater Nitrate Workgroup as per County Board Resolution 17-5A-282. The original deadline was set for December 31, 2017 and was extended in 2017 until December 31, 2020. The Land Conservation Committee and Board of Health along with the committees represented on the workgroup request the deadline be extended to December 31, 2025 to continue:

Obtaining necessary data from monitoring the groundwater at the nitrate reduction project located on the County farm and expand the project into other watersheds where data is required to make rational assessments;

The establishment of the Farmer Led Groundwater Group furthering the communication of BMPs to landowners throughout the county and whereby gaining additional data;

Develop a 9 Key Element Plan with the DNR to improve nitrate reduction strategies; and partnering with the NRCS to implement BMPs to reduce nitrates in groundwater through a newly acquired Source Water Protection Project in Turtle Creek watershed, along with a planned National Water Quality Initiative in the Southeast portion of the County and examining groundwater responses.

Continuation of the Workgroup will allow it to refine its recommendations of nitrate reduction in the County's groundwater aquifers.

The workgroup is currently meting four to six times a year to review updates, appraise progress, and guide county departments on pending actions.

WHEREAS the Rock County Board of Supervisors recognizes that rising carbon emissions are
exposing and will continue to expose Rock County citizens to the risks of increasing extreme heat in
the summers, heavier rainstorms, as well as more frequent and severe flooding; and

5 WHEREAS, according to the U.S. Environmental Protection Agency, Rock County, being part of the
6 State of Wisconsin, has warmed about two degrees Fahrenheit over the past century, and annual
7 precipitation has increased five to ten percent over the last half century; and

9 WHEREAS, according to the National Weather Service, flooding in Rock County near the Rock River
10 is likely due to recent warming trends over the last 30 years, with historic high water crests in 2008,
11 2013, 1993, 2018 and five recent high crests in 2018 and 2019. The information is based on Rock

River recording stations at Lake Koshkonong, Newville and Afton. High groundwater levels, increased
 snow pack and increased rainfall events will accentuate the probability of increased future flood events.

WHEREAS climate change is having and will increasingly have adverse effects on Rock County's
infrastructure, recreational opportunities, and area aquatic and land ecosystems, as well as the area's
tourism and agricultural industries; and

19 WHEREAS, action is needed at the national level to address climate change in a timely and effective 20 manner;

WHEREAS economists overwhelmingly support carbon fee and dividend legislation as sound
 economic policy in its own right and the most effective, most efficient way to reduce emissions; and

WHEREAS carbon fee and dividend legislation would create jobs, grow the economy, save lives, and reduce greenhouse gas emissions here in Rock County,

EXECUTIVE SUMMARY

Rock County citizens are growing increasingly alarmed by the effects of climate change on their way of life. Citizens are aware that our changing climate is affecting Rock County agriculture, tourism, infrastructure, health, and the overall quality of life here. Rock County citizens are experiencing difficulty in planting and harvesting crops, and they are observing more frequent flooding of area rivers and streams as well as damage to roads and bridges and to business and residential structures. They are struggling to adjust to temperature extremes that threaten traditional winter and summer recreational and economic activities. Citizens understand the broader global impacts of climate change, and they want the government to act.

In a 2019 Yale Climate Opinion poll, an estimated 70% of Rock County residents agreed that fossil fuel companies should be required to pay a carbon tax; 75% of county residents agreed that carbon emissions should be regulated by the government. At two recent Janesville farmers' markets in 2019, over 200 citizens took time to write letters to their Congressmen asking for federal legislation to enact a tax on carbon. In January, 2020, the Janesville city council, in response to citizen pressure, passed a resolution calling on Congress to pass effective climate legislation.

Municipalities and counties throughout the state and country are taking steps toward sustainability and toward building resiliency in the face of our changing climate, but only a federal response can quickly and effectively reduce the carbon dioxide emissions that are causing the rise in global temperatures, a rise that, unchecked, will result in serious and irreversible threats to our way of life here in Rock County.

American economists overwhelmingly support a tax on carbon as the best approach to addressing the climate crisis. Over 3500 American economists have signed a statement endorsing carbon fee and dividend legislation as the most effective way to quickly reduce carbon emissions. Carbon fee and dividend plans put a fee on fossil fuels at the source (the port, the mine, the well). The money from this tax would be distributed regularly to citizens as a dividend. There are a number of carbon fee and dividend proposals now in the House of Representatives. All involve a rising tax on carbon. They differ in how steep that rise might be, on how that dividend money should be allocated, and on specifics of the border adjustments that are necessary to ensure American competitiveness.

All would represent what many scientists and economists see as a basic first step in a government response to the climate crisis.

In supporting this resolution, The Rock County Board of Supervisors would join the many municipalities and counties across the state and nation that have already endorsed such legislation and would amplify local citizens' calls for a meaningful response to a serious threat to our way of life.
