## **Staff Report:**

1. <u>Site Manager Update:</u> Joyce Lubben reported that the number of diners at Riverview is increasing. There are currently 26 diners each day compared to an average of 15 at the end of 2009.

Mike Glasgow, RD from GWAAR, instructed a Serving Safe Food course. Seven people completed the certification exam.

The site managers' meeting was held on March 9, with the topics being the spring/summer menu and communication.

2. <u>Food Recall:</u> A widespread food recall of hydrolyzed vegetable protein (HVP) products was issued. This is a flavor enhancer used in a wide variety of processed food products. A list of commonly used products with HVP was distributed.
