6. COMMUNICATION

A. Chair Remarks

Amanda Sookraj welcomed Bill Wilson to CAI Board of Directors.
 Bill is replacing Jeremy Zajac. Bill is representing Rock County Public on CAI. He is representing the Rock County Board of Supervisors District 5.

B. Executive Directors Report

- i. IT upgrades: Payroll systems, data base software, Accounting system, phone systems and virtual classroom.
- ii. Staff have had opportunities to become vaccinated
- iii. CAI is working with Rock County Health Department with outreach to the African American and Hispanic communities regarding the CV19 vaccine.
- iv. New Resource Development Manager is starting at CAI on Monday March 1.
- v. Facility updates: upgrades to security to main sites.
- vi. Partnerships are developing with the Lincoln Academy in Beloit. Possible partnerships with CAI's Fresh Start program.

C. Deputy Director Report

- i. Reviewed the Key Results. Lynn talked about the breakdown of participants in Rock and Walworth County.
- ii. Transitional Jobs has greatly increased with enrollment.
- iii. Distance Learning Classroom will be ready approximately two weeks. This allows CAI to provide in person and virtual at the same time.
- iv. Researching and exploring key card access to sites.

D. Housing/Housing Development Report

- i. Fair market rent in 2021 is \$675 for one bedroom with utilities in Walworth County.
- ii. 1516 Nelson sale fell through at the last minutes. The buyers struggled with the financing due to the FHA loan. However, it went back on the market the next day and three offers came immediately. Another offer has been made and hope to close late March at sale price of \$130,000.
- iii. WERA: (Wisconsin Emergency Rental Assistance). Prescreen went live late afternoon on CAI's website. Sole purpose is to keep renters in the current units. Maximum is 15 months of rent (12 months of arrears and 3 months paid forward).
- iv. Rapid Rehousing, 8 households looking for housing at this time.
- v. Two new households for Permanent Supportive Housing.
- vi. Twin Oaks, wait list.
- vii. Discussion regarding affordable housing options and Community Action will continue to explore and report on housing stock availability.

- i. Extremely successful holiday season in fundraising, especially Twin Oaks Shelter and AWARE.
