To: Rock County 4-H Horse & Pony Committee

The Rock County Fairgrounds manager has been informed that on February 26, 2017, an individual that associated with the Rock County 4-H Horse and Pony Tack Show was extremely rude and disrespectful to other patrons of the fairgrounds. This individual, when asked to move his truck out of a fire lane so people could exit and did not have to drive through the grass, responded with numerous obscenities directed towards the other patrons. This occurred three different times, with three Rock County officials present.

While the offending individual does not have any official leadership roles associated with the tack sale, he is perceived to be leader in the 4-H horse and pony community. This individual's daughter is the chairman of the tack sale, and he is the one the was responsible for handling the keys for the fairgrounds.

This type of behavior is inexcusable from anyone, especially those that should be acting as a role model to our youth. As a direct result of these actions, the County of Rock has decided to impose a three-year ban on the Rock County 4-H horse and pony tack sale from its grounds. This ban has no correlation to the other events that the horse and pony 4-H project organize on the fairgrounds. After the three-year ban, the tack sale will be allowed again pending approval from the Rock County Agriculture and Extension committee.

We are sorry to inform you of this decision. Hopefully we can work together again in the future.
