# **Executive Summary** Authorizing Legal Services for the Rock Haven Facility Construction **Architect Services Contract** Significant cost overruns for the Rock Haven facility construction project surround the services of Eppstein Uhen Architects. The County previously retained the law firm Axely Brynelson, LLP of Madison, WI. to represent Rock County for the initial phase of pursuing cost reimbursement. It is recommended the law firm be retained for additional negotiations and mediation services in the amount of \$25,000. Funds for this activity would come from cost reimbursement.
