1. **Call to Order:** Chair Bostwick called the meeting to order at 7:09 pm.

Committee Members Present: Stephanie Aegerter, Rich Bostwick, Wes Davis, Kaelyb Lokrantz, Robert Potter, James Quade, Alan Sweeney and Jeremy Zajac.

- 2. **Approval of Agenda:** Supervisor Lokrantz moved to approve the agenda as presented, seconded by Supervisor Aegerter. **Motion Carried.**
- 3. Approval of Minutes –November 12, 2019 Public Hearing and November 12, 2019 LCC meeting: Supervisor Davis noted that Robert Potter was not at either of the meetings and should be noted as absent in the minutes. Supervisor Davis moved the minutes from the November 12, 2019 Public Hearing and the LCC meetings with the noted amendments, seconded by Supervisor Aegerter. Motion Carried.
- 4. **Citizen Participation, Communications, and Announcements:** Supervisor Davis noted he will be attending the upcoming Fall County Conservationist meeting in St. Point on December 12-13th.
- 5. Review Bills Paid: The committee reviewed the bills paid.
- 6. Erosion Control Storm Water Permit ECSW-2018-7, request a 6 month extension to complete permit conditions for Brimestone LLC The Reserve @ Stoney Ridge. Chris Murphy described area being the second phase of the Stoney Ridge and noted he is requested this extension. A short discussion followed. Supervisor Davis moved the extension request, seconded by Supervisor Quade. Motion Carried.
- 7. Land and Water Resource Management Program;
 - a. Approval of Cost Share Agreements. No agreements we presented for approval.
 - b. Approve 2019- 20 Carryover Request for Cost Share Agreements. Tom Sweeney reviewed the carryover requests. Supervisor Sweeney move to approve the carryover request as presented, seconded by Supervisor Quade. Motion Carried.
- 8. **Purchase of Agricultural Conservation Easements Update:** Tom Sweeney provided an update on the easements in the process. O'Leary Family Trust (donation) should be closed by the end of December 2019, and the Barlass Easement (purchase) should close by end of February 2020. Tom Sweeney stated he is still waiting for USDA-NRCS to release forms and deadlines for the 2020 program.

EXECUTIVE SUMMARY

Through Wisconsin Act 27 (1997-1999 Biennial Budget Bill), Chapter 92.10 of the Wisconsin Statutes was amended, creating a county land and water resource management-planning program. Wisconsin Administrative Code ATCP 50, details the requirement of the Land and Water Resource Management Plan. The original plan, approved in 1998, was one of the five original Land and Water Resource Management Plans in the State of Wisconsin. The original plan has been updated every five (5) years since the original plans publication date. The most current plan, dated 2019, incorporates new natural resource information.

This edition incorporates five natural resource management goals: Protect the quality and quantity of Groundwater; Protection of Farmlands; Protect quality of Surface waters; Improve and protect soil quality; and Protect and enhance habitat quality. It is a 10-year action and implementation plan that emphasizes cooperation with conservation partners in Rock County. The plan must be reviewed after five years by the State Land and Water Conservation Board.

The LWRM Plan is intended to complement and coordinate with existing plans rather than replace them. By focusing on the Rock County Land Conservation Committee (LCC) and Land Conservation Department's (LCD) strengths of conservation planning, information and education, technical assistance, and program administration, diverse interests act together in effective protection and enhancement of Rock County's natural resources.

In summary, the LWRM Plan outlines a comprehensive strategy for the implementation of protection of the natural resources. This will only be accomplished through continued partnerships with governmental agencies, landowners, non-governmental organizations, and the citizens of Rock County.
