## Staff Report:

- 1. <u>Rock County Senior Fair:</u> Julie Seeman reminded the group of the Rock County Senior Fair being held on October 26, 2012 at the Holiday Inn Express. There is still a need for volunteers. Please contact Ms. Seeman if you are available to volunteer.
- 2. <u>Caregiver Conference:</u> Julie Seeman provided material regarding the Caregiver Conference that will be held on November 9, 2012 at the Holiday Inn Express.
- 3. <u>Update on Stepping On Workshops/GWAAR Mini-Grant:</u> Joyce Lubben reported that two workshops will be concluding. She has received unofficial confirmation that Rock County will be awarded a mini-grant to expand the number of people who attend *Stepping On* workshops. The funding will cover the cost of training two new leaders and a workshop coordinator. The grant runs from November 1, 2012 June 30, 2013.
- 4. <u>s.85.21 Funding:</u> Joyce Lubben reported that additional state funding was received for the Elderly and Handicapped Transportation Funds to Counties due to the change in census for the county. This additional funding will be used to provide lift-equipped transportation from Rock County to Madison and a fixed route system for rural areas of the county.

- 5. <u>Mobility Management Projects:</u> Justin Svingen reported that he has submitted the 2013 New Freedom grant application. This application supports the Mobility Management position. He is working on developing a travel training video. Two individual travel training sessions have been scheduled. Mr. Svingen also attended the Beloit and Evansville Senior Fairs and made good outreach contacts. He also attended the Minnesota/Wisconsin Joint Transit conference.
- 6. State Audit of LogistiCare: Justin Svingen reported on the letter from Representative Penny Bernard Schaber, along with 51 other signees, to the co-chairs of the Joint Legislative Audit Committee requesting an audit of LogistiCare, the Medicaid transportation broker. At the present time, they have declined to conduct an audit, but are submitting a Letter of Inquiry to the Department of Health Services.
