<u>Terminal Building Update.</u> Mr. Burdick met with the Bureau of Aeronautics and Mead and Hunt. The plans are 65% completed. The three separate projects will be the shell of the building, refurbishing administration offices and conference rooms and the restaurant will be the last project.
