<u>Approval of Agenda</u>. Supervisor Arnold moved approval of the agenda as presented, second by Supervisor Yankee. ADOPTED.

<u>Citizen Participation, Communications and Announcements</u>. Supervisor Brill expressed concern about the amount of money invested in Rock Haven, that taxpayers are already taxed out, and the possibility of using sales tax to pay for a new building.

Mr. Smith said, for borrowing purposes, a project like Rock Haven could go out as long as 20 years so future taxpayers would be helping pay for it too.

Chair Podzilni asked if there was any way to ask for an extension past 2013 for the sprinkling of the current facility. Supervisor Bussie said there would not be.

Mr. O'Connell said they did some checking with other counties using Willis and all have reduced workers compensation costs. He added that if the County could save even \$50,000 it would pay the cost of hiring them.
