## **AIRPORT BUSINESS**

<u>Presentation from James Otterstein on Airport Video.</u> James discussed the new website for the Airport and the video available on the website was shown to the Committee. The Committee commended James for his work. Chair Yankee would like it shown to the entire County Board.

<u>Set Rate for 2012 AirFEST.</u> Supervisors Diestler and Fox moved to set the rate the same as last year, 1.3% of ticket sales. Tom Morgan discussed ticket prices for AirFEST for the past several years. AirFEST will be held May 25-27, 2012. MOTION CARRIED.

<u>Update on Revised Minimum Standards and Rules and Regulations.</u> Ron went over these two documents with Rock County Corporation Counsel and appropriate changes were made. This will be placed on the next agenda for action. Discussion on the documents took place. Chair Yankee asked about concealed carry and Ron replied this was taken care of in Section 6.3.

<u>Update on Terminal Project.</u> Ron reported the Governor has signed AB 152 into law. This changes the Bureau of Aeronautics level of funding remodeling projects from \$500,000 to \$1.25 million annually. Ron stated we should be able to start the terminal project in the near future.

Supervisor Owens recommended using the Samuels Group. Ron stated it would be up to the State, not the County.

Airport Accounts Receivables. The report was distributed to the Committee.

Ron reported that the Janesville Jet Center is not interested in collecting landing fees. It was brought up at a previous meeting that perhaps the FBOs could collect the landing fees.
