<u>Approve Purchase of Equipment – Three 4-Wheel Drive Tractors with Cabs.</u> Supervisors Bussie and Richard moved to purchase three 4-Wheel Drive tractors with cabs from low bidder, Triebold for \$181,954 (\$60,651.33 each). MOTION CARRIED.

<u>Approve Purchase of Equipment – One 2-Wheel Drive Tractor with Cab.</u> Supervisors Bussie and Richard moved to purchase one 2-wheel drive tractor with cab from Johnson Tractor for \$34,425. MOTION CARRIED.

<u>Approve Purchase of Equipment – One Hydroseeder.</u> Supervisors Richard and Bussie moved to purchase one hydroseeder from low bidder, Jefferson Equipment for \$43,995. MOTION CARRIED.

Approve Purchase of Rubber Tired Compactor at Auction. Ben explained they would like to purchase a used compactor at an upcoming auction and asked for authority to spend no more than \$9,999. Supervisors Bussie and Richard moved to purchase at auction one rubber tired compactor and authorized Mike Turk to spend no more than \$9,999. MOTION CARRIED.

<u>Approve Resolution – Jurisdictional Transfer, CTH M near Milton.</u> Supervisors Bussie and Richard moved the resolution. Ben explained why this jurisdictional transfer was needed. After the completion of the STH 59 project, there was confusion as to who had jurisdiction over what roads. This jurisdictional transfer will clear that up. MOTION CARRIED.

<u>Approve Resolution – William Powell Retirement.</u> Supervisors Richard and Bussie moved the resolution recognizing William Powell. MOTION CARRIED.

Approve Resolution – Construction of a Parking Area by the Town of Clinton on the Pelishek-Tiffany Nature Trail. Supervisors Bussie and Richard moved the resolution. Ben explained this resolution and easement will take care of a drainage problem at this location and the Town will build a parking lot for trail users. MOTION CARRIED.

<u>Approve Bridge Aid Petition – Town of Spring Valley.</u> Supervisors Richard and Bussie moved the bridge aid petition from Spring Valley for \$22,556.70, split 50/50 with the County) on Keesey Road. MOTION CARRIED.

<u>Presentation on Proposed Update to County Access Control Ordinance – Adam Pritchard, County Engineer.</u> Adam's presentation covered all aspects of updating the ordinance including roads to be deleted and roads to be added. He included a timeline of the ordinance change that would have the ordinance completed and passed by the County Board some time in November.
