May 8, 2014

<u>Call to Order</u>: Chair Gubbin called the meeting to order at 12:04 p.m. in Conference Room 519 on the fifth floor of the Rock County Courthouse-West.

<u>Committee Members Present</u>: Chair Tom Gubbin, Supervisor Sandy Kraft, Judge James Daley, Charmian Klyve, Eric Nelson, and David O'Leary (at 12:25).

Others Present: Elizabeth Pohlman McQuillen, Criminal Justice System Planner/Analyst and Supervisor Billy Bob Grahn.

<u>Approval of the Agenda</u>: Mr. Nelson moved approval of the agenda as presented, second by Ms. Klyve. ADOPTED.

<u>Approval of Minutes from Meeting on September 26, 2013</u>: Judge Daley moved approval of the minutes, second by Supervisor Kraft. ADOPTED.

<u>Approval of Resolution Proclaiming May 2014 Drug Court Month</u>. Ms. Klyve moved approval of the resolution, second by Judge Daley. ADOPTED.

Discussion regarding Evidence-Based Practice Decision Making (EBDM) Initiative. Chair Gubbin handed out information about the EBDM initiative and went over the Roadmap. Mr. Nelson said where people get hung up, is that everyone is "for" it in the abstract, but when system wide changes are considered, things get territorial. He said it starts with universal risk assessments which are used at every step in the process and you need right sized interventions. He asked if it would be beneficial to have a neutral facilitator.

Judge Daley asked what haven't we got/done and where do we get hung up? He said there has to be a decision on the assessment tool and the main stakeholders need to be involved with that.

Chair Gubbin mentioned the malpractice analogy and the need to do the right thing. Judge Daley said there needs to be a decision where to put the money. Ms. Klyve said the AODA treatment area is bifurcated and needs to be better organized/coordinated. Judge Daley said a lot of people have access to treatment post-adjudication and some before adjudication, but asked if people can be identified prior to an arrest/criminal justice involvement.

Mr. O'Leary said the State is working with NIC and he expects Wisconsin to be chosen for the statewide EBDM rollout. He said the State is also working with the Pew Center.

Chair Gubbin asked the group to look at the Readiness Checklist. Judge Daley said we should get medical providers involved. He said we have to show that all stakeholders agree and support the EBDM initiative.

Mr. O'Leary said his new Deferred Prosecution Director will also be involved with this process.
