Approval of Minutes – March 26, 2009.

6.A. Creating Chapter XXIX of the Rock County Code of Ordinances – Rock County Zoning Ordinance: Airport Overlay Zoning District (AOZD); Repealing Section 16.38 (First Reading and Public Hearing). Resolution No. 09-4A-241

Chair Podzilni declared the Public Hearing open. No one spoke.

Chair Podzilni declared the Public Hearing closed. This is the first reading of the Ordinance and requires no County Board action at this time.

7. Citizen Participation, Communications and Announcements.

Connie Robers of Beloit addressed the board about the Vision 2020 campaign, a statewide initiative to end childhood poverty and was presenting with Karen Lisser. The goals of this campaign are to broaden awareness and pursue solutions through community engagement. Ms. Robers shared some statistics and encouraged the board to pass the resolution (12.I) supporting the Vision 2020 campaign goal to eliminate child poverty.

Supervisor Brill shared highlights from the 2007 Wisconsin Traffic Crash Facts as provided by the Wisconsin Department of Transportation, Safety and Consumer Protection Division. The Wisconsin's Highway Safety Clock reported that there is one person killed every 11.9 hours; one person injured every 10.4 minutes; one driver age 19 or under in a fatal or injury crash every 1.0 hours; one person injured or killed in speed-related crashes every 46.8 minutes; one person injured or killed in alcohol-related crashes every 1.5 hours; one motorcyclist injured or killed every 3.2 hours; one pedestrian injured or killed every 6.3 hours; one bicyclist injured or killed every 7.7 hours and one school bus occupant injured or killed every 63.5 hours. There was one traffic crash every 4.2 minutes on Wisconsin Highways in 2007.

Supervisor Fizzell commended the staff for their presentations to the Legislators at the recent budget listening sessions. He felt that Phil Boutwell did an outstanding job.

Supervisor Diestler invited all to the 2nd Annual Chili Extravaganza on Saturday May 2, 2009 at the UAW Local 95 Union Hall located at 1795 Lafayette Street in Janesville – gates open to the public at 11:00 a.m. Proceeds benefit the Janesville Area Special Olympics and South Central Wisconsin Red Cross.

Supervisor Ott invited all to the Annual Earth Day Celebration on Wednesday, April 22nd at UW-Rock County where the G.R.E.E.N. Scene is hosting from 10am to 1pm. Enjoy campus prairie restoration with Dr. Bob McCallister, live raptors from Hoo's Woods, entertainment from guitarist Jake Stottler, food and beverage, drop off old running shoes or small electronic devices and visit earth-friendly vendors/displays.
