10.A. Legislative Update - Phil Boutwell.

Assistant to the Administrator, Phil Boutwell presented a legislative update as it pertains to the state budget and it's impact on County services and the 2010 Rock County Budget. A handout comparing the Governor's proposed budget with the Joint Finance Committee revisions on Rock County's budget was given to Supervisors. The initial Governor's impact on the County appeared to be in the area of \$2.1 million but the 2010 impact on the JFC revisions has closed the gap to roughly \$1.3 million, which is headed in the right direction. It is rumored that the Assembly and the Senate will move quickly on the budget and it could be to the Governor in a

few weeks, but Mr. Boutwell and several others are still lobbying for improvements. Of the \$1.3 million dollars in cuts to the County by the state, \$1,149,810 falls in the human services area; specifically child welfare, income maintenance and mental health.

The budget process among departments is set to begin with a Department Head meeting June 12 where a timeline and instructions will be given. Much should be known by July 15.
