PARKS BUSINESS

Approve Resolution Endorsing the Rock County Beloit-Janesville Bicycle Route Corridor Master Plan and Feasibility Study. Supervisors Fox and Arnold moved the resolution. Lori stated this resolution endorses the feasibility and planning process of the Beloit-Janesville Trail. Supervisor Diestler asked if funding was involved and Lori replied there is no funding at this time. Dean Paynter discussed the process of obtaining perpetual easements on the parcels involved. He explained the trail would run from Afton to Big Hill Park. At that point, the City of Beloit has plans to extend the trail to the Illinois trails. Supervisor Bussie asked what the time limit is and Dean replied 3-5 years. MOTION CARRIED.

Approve Contracts #1 and #2 with MSA to Prepare Bidding Documents for Turtle Creek Parkway Building Improvements. Supervisors Fox and Diestler moved the contracts. Supervisor Arnold asked if there was any information on the Delong property. Lori replied we are waiting for them to get back to us.

The possibility of a partnership with the Friends of Badfish Creek Watershed group was discussed.

Discussion on invasive species bike ride was discussed. Joleen stated this would focus on invasive plants.

The Committee was reminded of the upcoming Green Fund hike at Gibbs Lake Park on Friday night, February 17.

<u>Discuss Gibbs Lake House.</u> Lori and Joleen met with the tenants of the Gibbs Lake house and toured the property. Lori discussed work that needs to be done there. She stated the tenants have taken very good care of the property.

<u>Discuss Possible Trapping Ordinance Change to Meet Stewardship Grant Requirements.</u>
Jeff Kuglitsch discussed the liability involved in allowing trapping in any county park that receives Stewardship Grant funds. It is a policy decision for this Committee. Discussion took place. The consensus of the Committee was to move forward with applying for Stewardship Grant funds. Lori will prepare a resolution for action by this Committee.
