Approve Change of Controlled Access Driveway on CTH M. Supervisors Bussie and Arnold moved the request. This request comes from the Rock River Thresheree group. They have requested a modification to a driveway approximately 1,783 feet east of USH 51 on that property to allow two lanes of traffic inbound to the parking area during the Labor Day weekend activities they host nearby. This should minimize or eliminate cars having to wait in the roadway to enter the park. They plan to have all traffic exit the park at the main gate on County Trunk Highway M and would not use this proposed access for exiting.
