1. **Call to Order:** Chair Bostwick called the meeting of the Land Conservation Committee to order at 7:15 p.m.

- 3. Approval of Minutes March 3, 2010 and March 10, 2010: Supervisor Combs motioned to approve the March 3, 2010 minutes as presented, seconded by Supervisor Arnold. Motion Carried. Supervisor Fizzell motioned to approve the March 10, 2010 minutes as presented, seconded by Supervisor Quade. Motion Carried.

- 5. **Bills and Transfers:** Supervisor Wiedenfeld motioned to approve the bills, seconded by Supervisor Combs. **Motion Carried.**

 - A) Approval of cost share agreements. Supervisor Fizzell motioned to approve the agreements as presented, seconded by Supervisor Quade. Tom Sweeney reviewed cost share agreements for: Sweeney Farms, Jeff Waller, Rock Prairie Farms, Hiemstra Rev. Trust, Lillian Ballmer, and James Connell. Supervisor Sweeney abstained from the vote. Motion Carried.
 - **B)** Approval of 2011 SWRM Grant Application. Supervisor Sweeney motioned to approve the 2011 SWRM Grant Application, seconded by Supervisor Quade. Tom Sweeney reviewed the grant application. **Motion Carried.**
- 8. **Approval of 2010 Gypsy Moth Suppression Program Grant Agreement.** Supervisor Arnold motioned to approve the agreement as presented, seconded by Supervisor Wiedenfeld. Tom Sweeney reviewed the agreement. Discussion centered on the Beloit area suppression efforts. The committee requested that Anne Miller make a presentation to the committee at the May meeting. **Motion Carried.**
