Referendum**City of Brodhead**

Under state law, the increase in the levy of the City of Brodhead for the tax to be imposed for the next fiscal year, 2023, is limited to 2%, which results in a levy of \$2,020,292. Shall the City of Brodhead be allowed to exceed this limit and increase the levy for the next fiscal year, 2023, for the purpose of funding increased operating costs by a total of 10% which results in a levy of \$2,220,293 and include the increase of \$200,000 for fiscal years 2023 through 2027?
